- (b) Inform Lancashire County Council that in respect of Application No. LCC/2018/0043 regarding the provision of a multi-use games area with 3m high ball stop fencing at Lancaster Road Primary School, Lancaster Road, Morecambe the Town Council did not object to the proposal but would support the recommendations set out in the County Highways Officer's letter dated 24th September 2018.
 - (c) Inform Lancaster City Council that in respect of Application No. 18/00895/ADV regarding the display of 2 externally illuminated fascia signs at Gala Club, Marine Road East, Morecambe the Town Council would not support the proposed externally illuminated double-sided totem sign contained within the application on the basis of its prominence, dominance, scale, inclusion of inappropriate materials and inappropriate siting in relation to key views within the Conservation Area.
 - (d) Inform Lancaster City Council that in respect of Application No. 18/00943/FUL regarding the demolition of existing garage and erection of a detached garage at 10 Windermere Avenue, Morecambe the Town Council would not object provided that the proposed building was to be used as a garage only.
- (3) That 5 tickets be purchased for the North West in Bloom Presentation event to be funded from the Council's Morecambe in Bloom in budget, with the winners of the Amateur Gardener and Business Competitions in Morecambe in Bloom 2018 being invited to attend the presentation ceremony with the Town Clerk.

Minutes from the Planning, Development and Environment Committee Meeting held at 7.00 pm on Monday 1st October 2018

24. Minutes of Meeting of Planning Development and Environment Committee held on 3rd September 2018

Resolved:

That the minutes of the Planning Development and Environment Committee held on 3rd September 2018 be signed as a correct record.

25. Proposed development at land off Fulwood Drive, Morecambe

Representatives of Smith & Love Planning Consultants gave a short presentation outlining initial proposals for the potential development of land off Fulwood Drive Morecambe which was owned by Oakmere Homes. The land in question was not within the Town Council's boundary but any subsequent planning application and subsequent development would affect residents within the Town Council area as access to the new development would be from Fulwood Drive.

The purpose of the presentation was to ascertain the Town Council's initial views on the proposal before the scheme was further developed and prior to any planning application being formulated. Fifteen residents of Fulwood Drive attended the meeting and gave their views on the initial proposals.

The Consultants outlined that the land was currently classified as Green Belt which would prohibit a planning application for residential development being submitted. However the City Council's Local Plan which would be subject to inspection in early 2019 was proposing that the land be re-designated as a brownfield site. This would then allow a potential detailed scheme and planning application to be prepared and submitted. It was therefore likely that a planning application would not be submitted for some time. This was a not a formal planning consultation but an exercise by the Consultants to gauge the views of the Council particularly as the Council was preparing a Neighbourhood Plan which could seek to include policies to control such developments and the housing development in general. However, the Consultants reminded the Committee that the City Council was obliged by Government Policy to meet its housing provision targets and that there was very little space within Morecambe to undertake further developments to contribute to this target.

The initial proposals were to develop half the site. The part of the site that would not be developed was the portion adjacent to Torrisholme Barrow which was considered an important historical area which should not be developed. The initial proposal would be for around 150 properties including affordable units to comply with Government policy.

The Consultants stressed that the consultation at this time was merely about the principles of development and no final decision had been taken by the land owner on the exact scheme to be considered for inclusion on any subsequent planning application.

Committee members and residents expressed their concerns about the proposed development of this area of land for the following reasons:

- Access to the site was inadequate – this was due to the limited and narrow access for Fulwood Drive which would not be sufficient for both construction and future resident traffic, and would increase the likelihood of accidents occurring on Fulwood Drive;
- Flooding – the land was low lying with very poor drainage and was often in standing water particular during the winter and after long periods of wet weather. Indeed, the completion of the Bay Link suggested that this had contributed to additional flooding issues within this part of Morecambe. Further development in this area would only add to this serious problem particularly as the current drainage system on Fulwood Drive could not cope with the amount of water during prolonged wet weather;
- The proposed development site was on a substantially different level which would add to the flooding issue and the development would not blend in with bungalows on Fulwood Drive;
- Inappropriate noise levels for residential development which would be caused by the main line and branch line railways bordering the proposed development site. The Consultants outlined that noise surveys had been undertaken which suggested noise levels were satisfactory although the development would be moved slightly further away from the main railways line if it went ahead following the findings of the survey. Residents suggested that the noise of the daily nuclear waste train was very loud and occurred during unsociable hours;
- Severe impact on traffic in the whole Bare/Torrisholme area due to the inappropriate road infrastructure available to tolerate the considerable additional vehicle movements per day should 150 properties be developed.

Resolved:

That Council be recommended to:

- (1) Thank the Consultants for attending the meeting and bringing this matter to the Council's attention.**
- (2) Request the Clerk to arrange an early meeting with representatives of Slyne-with-Hest Parish Council as the land in question fell within their area, to ascertain their views on the proposals and how they proposed to deal with any forthcoming proposals in the emerging Slyne Neighbourhood Plan.**
- (3) Request the Clerk to discuss with the City Council and Slyne-with-Hest whether this area of land could be included within the Morecambe Neighbourhood Plan area.**
- (4) Request the Clerk to ensure that the residents who attended the meeting are kept up to date of any future developments regarding this matter.**
