It was unanimously resolved to defer the minutes of the meeting held on 2 July 2020.

Committees

Personnel Committee

It was resolved unanimously to constitute a Personnel Committee, adopt the Terms of Reference and approve a membership of eight members - Cllrs A Ashworth, J Ashworth, P Heath, P Anderton, M Evans, R Cleet, J Hanson, M Pattison.

Finance and Governance Committee

It was resolved to constitute a Finance and Governance Committee, adopt the Terms of Reference and approve a membership of nine members. The Council elected eight members to the Committee - Cllrs R Dennison, J Firth, M Balcer, J Bates, P Heath, J Pilling, J Ashworth, P Ross-Clasper.

Festivals, Sponsorships and Events Committee

It was resolved to constitute a Festivals, Sponsorships and Events Committee. It was resolved to adopt the Terms of Reference subject to an amend to section 3(viii) to read "To ensure that organisers complete any necessary risk assessments and obtain required permission, event licenses, or other agreements that are required to be obtained prior to any event". The Council elected nine members to the Committee - Cllrs M Pattison, J Goodwin, D Whittaker, P Clarke, P Ross-Clasper, P Heath, A Ashworth, V Boyd-Power, J Ashworth.

Meeting was adjourned for a small break and reconvened at 21:14.

Grants Committee

It was unanimously resolved to adopt the Grant Criteria subject to the deletion of "for private gain" in section 1(f), the amend to section 1(l) to read "..not to fund the project, unless the application is returned in a substantially modified form", and the addition of section 1(i) to read "organisations applying for a grant of less than £1,000 will be required to submit invoices to support their application. Organisations applying for a grant of £1,000 or more, but less than £10,000, will be required to submit invoices and accounts to support their application. Organisations applying for a grant of £10,000 or more will be required to submit independently audited accounts to support their application."

It was unanimously resolved to adopt the Grant Application Form with an inclusion of an additional budget template in section 13.

It was unanimously resolved that "Morecambe Town Council area" would clarify the scope of the eligibility.
