## Morecambe Town Hall

In the name of the people of Morecambe and Heysham, it was resolved that Morecambe Town Council submits an expression of interest to Lancaster City Council in the future running and ownership of Morecambe Town Hall (to include building and land up to the boundary).

It was resolved to procure the services of Wellers Hedleys at a cost of £225ph to facilitate a Community Asset Transfer bid and work with the Proper Officer to draw up an EOI to enable the drafting of a Proposal of Feasibility to be considered by Morecambe Town Council and Lancaster City Council at a future date.

It was resolved Morecambe Town Council requests that Lancaster City Council commits to keeping a customer service desk open in Morecambe for the benefit of local residents.

It was resolved to form a working group consisting of all members to explore working towards taking over services currently provided by Lancaster City Council and Lancashire County Council, namely highway weeding, public gardens, street cleaning as and when an appropriate business case can be proven for feasibility.
