- 7. **Petty Cash** to note that events income has been previously been received in cash. Following the election, bank signatories were unable to release salary payments and petty cash funds had to be used to pay employees (and all sums have since been clawed back from subsequent payslips). It is important that the Council's Financial Regulations align to actual practice, and it is recommended that the F&G Committee recommend an increased sum to facilitate officers to manage a petty cash float more suitable for the increasing size of the Council.
- 8. **Procurement Threshold Changes** to note that the Regulations set by the Public Contracts Directive (Financial Regulation 11 (1) c) have amended thresholds for tender procurement effective 1 January 2024.

Thresholds currently applicable are:

- a) For public supply and public service contracts £214,904 (inc VAT)
- b) For public works contracts 5,225,000 Euros £5,372,609 (inc VAT)
- 9. **Publication Scheme** to recommend for approval, the Council's Publication Scheme (must be reviewed at least annually).
- 10. Draft Budget 2024-2025 to consider the draft budget 2024-2025 and agree actions.
